1. Business ethics

- ► Supplier complies with all applicable local laws and regulations.
- ► Supplier refrains from any form of corruption. All business is conducted with integrity.
- ► All business transactions with Corbion are accurately and completely recorded, and guarantee legal and fiscal compliance.
- Supplier reports possible violations of the Supplier Code to Corbion.

2. Human rights & labor conditions

- Supplier does not use child, forced or compulsory labor
- Supplier does not discriminate based on nationality, race, religion, gender, age, sexual orientation, disability, etc.
- ➤ Supplier respects the right of their employees to freedom of association and has an employee grievance process.
- Supplier complies with relevant International Labor Organization (ILO) standards.
- Supplier provides safe and healthy working conditions for all employees, contractors and visitors.
- ➤ Supplier provides appropriate wages and working hours, according to applicable laws, for all employees. Suppliers should seek to ensure that all workers are paid a "living wage" (i.e. the minimum remuneration to support basic needs in the area of operation).
- ➤ Supplier provides clear written guidelines to employees explaining the terms and conditions of their employment, and their rights and duties.
- ► Supplier prevents and mitigates adverse social and environmental impacts on their local communities.

3. Environment

- ➤ Supplier complies with all relevant environmental laws and ensures that the necessary permits are in place
- ➤ Supplier strives for continuous improvement of their environmental performance by minimizing the use of raw materials, energy and water, emission to air, water and soil and the production of waste, including food waste and landfill usage. Emission of greenhouse gases and impacts on biodiversity are minimized.
- Suppliers provides transparency to customers and other relevant stakeholders about the environmental and safety aspects of their products and production processes.

4. Product quality and safety

► All products and services meet the Corbion quality and safety criteria as required for supplier compliance.

5. Intellectual property
