

Highlights Q3 2020

- Organic net sales increase of 5.2%, volume driven
 - Core activities (organic sales growth +6.4%)
 - Sustainable Food Solutions: Strong growth in Preservation, slight growth in Functional Systems, strong recovery in Single Ingredients
 - Lactic Acid & Specialties: High growth across all product segments except for biopolymers (postponements elective surgeries) and lactic acid to Total Corbion PLA jv (phasing)
 - Incubator: Decline due to significant shift to Q4 (omega-3)
 - Non-core activities (organic sales growth -0.7%): Lower emulsifier sales
- Adjusted EBITDA Q3 of € 44.6M (Q3 2019: € 40.7M): +9.6%
 - Organic increase of 18.2%

YTD 2020 key items

- Preservation: Strong consumer demand for meat products with extended shelf-life
- Functional Systems: Grew slightly in Q3 after volatile H1
- Single Ingredients: Stable YTD in which Q3 compensated for declines in H1 due to internal lactic acid allocation decisions

YTD 2020 key items

- All product segments grew with exception of biopolymers
- Biopolymers is slightly declining due to postponements in elective surgeries
- Total Corbion PLA joint venture continues to perform above expectations

- Adjusted omega-3 market approach resulted in initial positive customer response
- Organic net sales decrease in Q3 is mostly due to significant quarterly volume delivery shift from Q3 to Q4
- Q4 expected to be the strongest quarter of the year

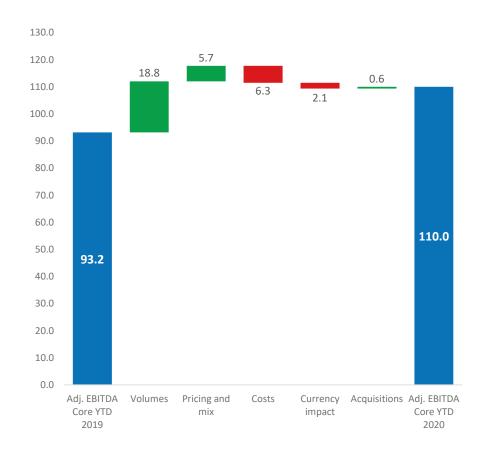

Core activities

- Organic increase due to higher volumes and better price/mix
- Costs increase, but less than planned for due to Covid-19 impact (travel, hiring, etc)



Outlook FY 2020

- On track to reach target levels in 2020
- Uncertainty regarding the Q4 business performance is greater than usual due to the potential impact of the COVID-19 pandemic
- No change to full year guidance
 - Organic net sales growth core activities in the 4-7% range
 - Adjusted EBITDA margin core activities >15%
- Total capex for 2020 € 90-100 million (was: € 80-90 million) due to lactic acid investment program expansion
