This committee is responsible for reviewing and approving our advocacy initiatives. We strictly avoid any activities that could be perceived as unethical, ensuring that they reflect our commitment to sustainability, integrity, transparency and responsible business as laid out in our Code of Business Conduct that is published on the Corbion website. Corbion does not make political contributions in any form, ensuring that our advocacy efforts remain focused on policy engagement that aligns with our sustainability goals and corporate values.
