

**TRIPTYCH
AMENDMENT OF THE ARTICLES OF ASSOCIATION
CSM N.V.**

GENERAL

The objective of the amendment to the articles of association is to bring the articles in line with recent changes in the Dutch Civil Code (*Burgerlijk Wetboek*), the Financial Supervision Act (*Wet op het financieel toezicht*), the Securities Giro Transfer Act (*Wet giraal effectenverkeer*), and other regulations.

The lay-out of the articles of association has been amended in order to approve the overall readability of the articles of association. A further explanation on the renumbering and references to renumbered articles shall not be provided for. Furthermore, some textual amendments will be proposed, without affecting the content of the articles of associations.

With respect to the proposal to amend the articles of association, the voting at the extraordinary general meeting shall take place in three tranches. The following proposals will be put to the vote at the General Meeting separately: the proposal to (i) change the name of the Company into Corbion N.V. (article 2, paragraph 1), (ii) amend the maximum number of shares the Company may acquire in its own capital (article 7, paragraph 1), and (iii) amend the other articles of the articles of association to bring them in line with recent changes in Dutch law.
